THE CUMULATIVE EFFECT OF COSTS ON RETURN

The total costs and charges deducted for each fund will have an impact on the investment return you might get. Whilst performance can't be guaranteed, we can give you examples of how the charges might affect what you get back.

For Class A, without fees the performance you could have achieved would be 107.6% after 7 years; after fees the performance achieved is 23.1%. This equates to a reduction of -€8,455 on your investment return. For class B, without fees the performance you could have achieved would be 107.6% after 7 years; after fees the performance achieved is 27.2%. This equates to a reduction of −€8,037 on your investment return.

The impact of charges and costs on your investment will vary depending on your investment term.
