This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The product is in the form of a certificate issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by The Goldman Sachs Group, Inc.

Term

The product has a fixed term and will be due on August 4, 2028.

Objectives

The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the index MSCI World Index (Price Return EUR) (the **underlying asset**). The product has a fixed term, ending on August 4, 2028. Each certificate has a face value of EUR 1,000. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Main Segment). The subscription period is from May 29, 2023 to July 28, 2023. The issue date is August 4, 2023.

Repayment at maturity

On August 4, 2028, for each certificate that you hold you will receive the difference between (i) EUR 1,300.00 (i.e., 130.00% of the face value) multiplied by (A) the final reference price of the underlying asset divided by (B) the initial reference price of the underlying asset and (ii) EUR 300.00. However, if this exceeds EUR 1,403.00, you will only receive EUR 1,403.00 (the maximum payment) and if it is less than EUR 1,000.00, you will receive EUR 1,000.00 (the minimum payment).

The initial reference price of the underlying asset is the closing price on July 28, 2023.

The final reference price of the underlying asset is the arithmetic average of the closing price observed on each trading day rolling monthly from February 28, 2028 (inclusive) to July 28, 2028 (inclusive).


The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail investor The product is intended to be offered to retail investors who:

- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
- seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return and have an investment horizon of the recommended holding period specified below;
- accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are not able to bear any loss of their investment;

What are the risks and what could I get in return?

Risk indicator





The risk indicator assumes you keep the product until August 4, 2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before August 4, 2028. If we are not able to pay you what is owed, you could lose your entire

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's performance over up to 5 past years. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period for the product is 5 years as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis.
