The Europe Evolution fund is a fund actively managed by Lyxor Asset Management. The strategy implemented by the manager combines elements of financial analysis (resilience of the balance sheet and the business) and extra-financial analysis (by excluding securities of companies that do not comply with environmental, social and good governance criteria). The allocation of the Fund's assets to the securities selected is made using a quantitative methodology of equal risk weighting. The Fund uses a dynamic leverage mechanism aimed at stabilizing its risk profile between bull and bear market phases. As a result of its distribution policy, the Fund awards a fixed dividend of an annual value of EUR 5 per Fund unit (for a hypothetical net asset value of the Fund as of 13 August 2021 : EUR 122.43).

As a result, if the dividends paid by the underlying assets of the Fund are lower (respectively higher) than the fixed dividends detached, the net asset value of the Fund will be reduced (respectively increased) compared to an equivalent fund which distributes the actual dividends paid by the underlying assets. Without taking into account the dividends actually received by the Fund, the impact of distributing a fixed dividend on the net asset value of the Fund is greater in the event of a decrease in the value of the Fund in relation to its initial level (negative effect) than in the event of an increase (positive effect). Thus, in the event of a continuous downward trend, the fall in the net asset value of the Fund will be accelerated.

Type

This product is an unsecured debt instrument governed by English law.

Objectives

This product is designed to provide a return when the product is redeemed (either at maturity or when redeemed early). It is possible for the product to be automatically redeemed early based on pre-defined conditions. If the product is not redeemed early, both the return and the capital redemption amount will be linked to the performance of the Reference Underlying. Your capital will be fully at risk when investing in this product.

Automatic Early Redemption

On any Early Redemption Observation Date, if the level of the Reference Underlying is at or above the corresponding Early Redemption Barrier, the product will be redeemed early and you will receive:

100% of the Nominal Value plus the Early Redemption Coupon.

Final Redemption

On the Maturity Date, provided that the product has not been redeemed early, you will receive a final redemption amount.

- If the Final Level of the Reference Underlying is at or above the Final Barrier, you will receive: 100% of the Nominal Value plus the Final Coupon

- If the Final Level of the Reference Underlying is below the Final Barrier and is at or above the Capital Barrier, you will receive: 100% of the Nominal Value.

- Otherwise, you will receive the Final Level of the Reference Underlying multiplied by the Nominal Value. In this scenario, you will suffer a partial or total loss of your invested amount.

Additional Information

- The level of the Reference Underlying corresponds to its value expressed as a percentage of its Initial Value.

- The investor does not receive the dividend detached by the Fund but benefits indirectly from this dividend payout through the yield of the product. Also, in certain circumstances described above, the fixed dividend distribution payment could have a negative impact on the value of the Fund and consequently on the value of the product.

- The Initial Value of the Reference Underlying is its value observed on the Initial Observation Date.

- The Final Level is the level of the Reference Underlying observed on the Final Observation Date.

- Coupons are expressed as a percentage of the Nominal Value.

- Extraordinary events may lead to changes to the product's terms or the early termination of the product and could result in losses on your investment



WHAT ARE THE COSTS?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 9 years 11 months 30 days, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product by providing bid and offer prices expressed as percentages of the nominal value and the difference between the bid and offer prices (the spread) will not be more than 1% of such nominal value. If you want to sell the product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily or permanently suspended.
