You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

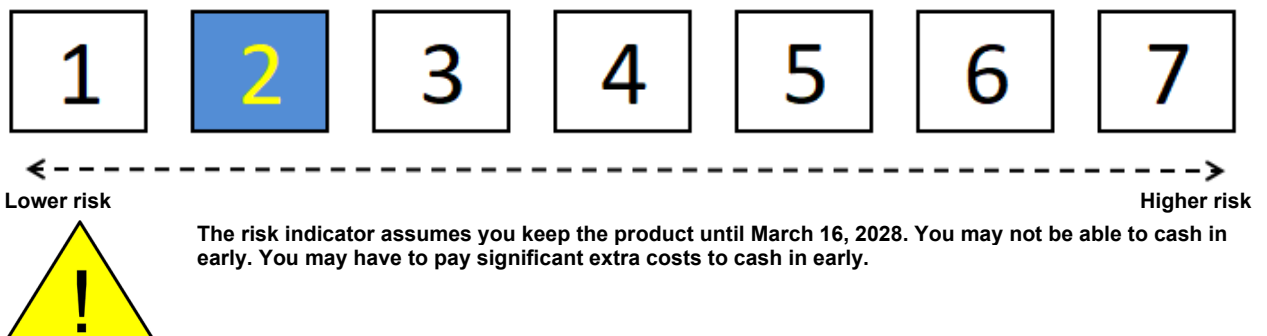
- Type** The product is in the form of a certificate issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by The Goldman Sachs Group, Inc.
- Term** The product has a fixed term and will be due on March 16, 2028, subject to an early redemption.
- Objectives** The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of Goldman Sachs Global Diversified Multi-Asset 5% Series 2 Index (the **underlying asset**). The product has a fixed term, ending on March 16, 2028. Each certificate has a face value of EUR 1. The issue price is 100.00% of the face value. The product will be listed on the Luxembourg Stock Exchange (Main Segment).
- Repayment at maturity:**
 On March 16, 2028, for each certificate that you hold, you will receive the difference between (i) EUR 1.65 (1.65% of the Nominal multiplied by A) the final reference price of the underlying asset divided by (B) the initial reference price of the underlying asset and (ii) EUR 0.5675. However, if this is less than EUR 1.00, you will receive EUR 1.00 (the minimum payment).
 The initial reference price of the underlying asset is the closing price of such underlying asset on March 9, 2023.
 The final reference price of the underlying asset is the average of the closing price observed on September 9, 2027, October 11, 2027, November 9, 2027, December 9, 2027, January 10, 2028, February 9, 2028 and March 9, 2028.
 The performance of the underlying asset is the closing price of the underlying asset on any day divided by the initial reference price. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail investor

- The product is intended to be offered to retail investors who:

 2. seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return and have an investment horizon of the recommended holding period specified below;

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before March 16, 2028. If we are not able to pay you what is owed, you could lose your entire investment.

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's performance over up to 5 past years. In the case of an early redemption, it has been assumed that no reinvestment has occurred. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period you may have to pay extra costs.

*This illustrates how costs reduce your return each year over the holding period. How long should I hold it and can I take money out early?

Recommended holding period: 5 years
