## What is this product?

This product is a structured investment. Your money will be used to buy securities issued by Investec Bank plc

### Objective

This product is denominated in EUR, has a term of 6 years and is linked to the performance of the EURO70 Index (the "Underlying").

### At the end of the recommended holding period

- The product will return a minimum of 85% of your initial investment.
- If the Underlying is below 100% of its starting level you will lose capital on a one for one basis. Capital loss is capped at 15%.
- If the Underlying is above 100% of its starting level, the product will also pay 150% of the growth in the Underlying above 100% of its starting level up to a maximum product return of 132%.

### Intended Retail Investor

This product has been designed for investors who are looking to potentially achieve capital growth over a term of 6 years. Investors will have a medium-low appetite to risk. They will be prepared to risk their capital in order to achieve higher returns. Investors will understand that the potential returns of this product are linked to the performance of the EURO70 Index. Additionally, investors will have knowledge and understanding of this structured product from supporting product literature and any advice they have received, as well as an understanding of financial markets.

## What are the risks and what can I get in return

### Risk Indicator



The risk indicator assumes you keep the product until 18 Dec 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7,

representing a medium-low risk class. This classification rates the potential losses from market movements during the term of the product as medium-low. Poor market conditions are unlikely to impact the capacity of Investec Bank plc to pay you.

You are entitled to receive back at least 85% of your capital. Any amount over this and any additional return depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in early.

If we are not able to pay you what is owed, you could lose your entire investment.

If Investec Bank plc experiences a credit event (i.e. becomes insolvent, defaults on its payment obligations, experiences a restructuring of its debt obligations or becomes the subject of governmental intervention), 100% of your investment will be at risk.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The table above shows the split of the reduction in yield shown in the costs over time table after a maturity of 6 years. ### How long should I hold it and can I take money out early

#### Recommended holding period: 6 years
