You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

► TYPE

This product is a certificate, a transferable debt instrument.

► OBJECTIVES

The objective of this product is to provide you with a return based on the performance of an underlying index.

On the Redemption Date you will receive in respect of each certificate:

1. If the Final Reference Price is greater than or equal to 125% of the Initial Reference Price: a payment in cash equal to 162.50% of the Notional Amount.
2. If the Final Reference Price is less than 125% of the Initial Reference Price but greater than or equal to 100% of the Initial Reference Price: a payment in cash equal to the Notional Amount increased by 250% of the Performance of the Underlying.

3. If the Final Reference Price is less than 100% of the Initial Reference Price but greater than or equal to 85% of the Initial Reference Price: a payment in cash equal to the Notional Amount decreased by the Performance of the Underlying. In this case you will suffer a partial loss of the Notional Amount.

4. If the Final Reference Price is less than 85% of the Initial Reference Price: a payment in cash equal to 85% of the Notional Amount. In this case, you will suffer a partial loss of the Notional Amount.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

► RISK INDICATOR



The risk indicator assumes you keep the product until maturity. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

You will receive payments in the product's currency, which may be different from your domestic currency. In this case, **be aware of currency risk**. The final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?
