## WHAT IS THIS PRODUCT?

#### TYPE

This product is a certificate, a transferable debt instrument.

#### OBJECTIVES

The objective of this product is to provide you with a return based on the performance of an underlying index.

On the Redemption Date you will receive in respect of each certificate:

- If the Final Reference Price is greater than or equal to 125% of the Initial Reference Price: a payment in cash equal to 127.50% of the Notional Amount.

#### RISK INDICATOR

The recommended holding period for the product is until 14 June 2028, which corresponds to the product's maturity.
